UNOPPOSED MOTION TO SUPPLEMENT THE RECORD

The Appellant, CHARLES ADELSON, by and through undersigned counsel and pursuant to Florida Rule of Appellate Procedure 9.200(f), moves the Court to direct the clerk of the lower tribunal to supplement the record on appeal in this case, and alleges:

1. Appellant Adelson is appealing his convictions and sentences (following a jury trial) for first-degree murder, conspiracy to commit murder, and solicitation to commit murder.

2. In reviewing the record on appeal, undersigned counsel discovered that the record is incomplete. An amended judgment was rendered on June 14, 2024.

3. Accordingly, Appellant Adelson requests the Court to direct the clerk of the lower tribunal to prepare a supplemental record on appeal containing the item listed in paragraph 2 of this motion. This item is necessary for full appellate review. *See Hampton v. State*, 591 So. 2d 945, 945-948 (Fla. 4th DCA 1991).

4. *Certificate of Counsel*. Opposing counsel (Assistant Attorney General Trisha Meggs Pate, Tallahassee Bureau Chief, Criminal Appeals) has been consulted and she does not object to Appellant Adelson's motion to supplement the record.

WHEREFORE, Appellant Adelson requests that the Court direct the clerk of the lower tribunal to prepare a supplemental record on appeal containing the item listed in paragraph 2 of this motion. Appellant Adelson also requests that the deadline for serving the Initial Brief be tolled/extended pursuant to Florida Rule of Appellate Procedure 9.300(b).
